





# Accreditation with the Chamber of Auditors

- The Master's degree in Accounting, Auditing & Taxation as available from May 2021 and retrospectively to 2016 has been accredited as equal to the German CPA exam by the Chamber of Auditors.
- Students with the professional goal of becoming auditors have the opportunity to complete two out of seven exams in the field of business administration/economics during their studies.
- In addition to the examinations, a placement exam and an additional oral exam must be taken during the course. Both exams are offered at least once per semester. There are no special requirements, such as work experience.
- There are five modules which are necessary to be successfully completed:







# Launch Your Career in Siegen

- Siegen offers so many opportunities. At Pace, you can gain the skills and experience you need to stand out in a competitive job market.
- The central target of the degree is training future auditors, tax advisors, and consultants, as well as other professions that are related to the areas of accounting, auditing and taxation, such as internal auditors, controllers, finance and rating analysts.
- The focused and highly qualified training is ensured by the interdisciplinary alignment of contents from the areas of accounting, auditing, taxation, business and tax law, corporate governance, and controlling.
- It is to enable students to, in particular, acquire skills in the execution of legally required audits, and knowledge and skills that enable them to meet their role as generalists and to solve interdisciplinary issues form the professional work of an auditor, tax or corporate consultant, in the scope of their education.





# Participation in the University Research

A university master's degree not only offers students the best possible qualification for a path to the professional exams but also provides entry into research and opens up the possibility of becoming Doctorates.

### **SUWI Institute**

- For students with doctoral projects, there are offers at House of Young Talents or the Siegen Institute for Corporate Taxation, Auditing, Accounting and Business Law (SUWI).
- The aim of SUWI is to improve knowledge transfer between the university and regional companies and institutions.
- Students can gain regular experience in collecting research. The framework of these projects, particularly in publications in special journals on current issues on accounting and taxation, there is the possibility of research under student participation in the white paper series of the SUWI Institute.







# Your Way to Us

The study places for the Master AAT are limited to a number of 40 students for one year in order to be able to maintain a personal mentoring relationship. Application is possible for the summer and winter term. In the application process, students must first register in the online application portal of the School of Economic Disciplines. Afterwards there are written application documents which needs to be submitted by post.

# Additional requirements apply to the master's degree:

Bachelor's degree in business administration or a comparable degree in economics which is at least 90 credit points

Minimum final grade: good (2.5)

At least 8 credit points from the field of law in German language

Knowledge of the English language at level B2

If you do not meet requirements 1 and/or 2, your suitability for the access to the master's program can be determined through an individual interview.
