## Seminar International Investment Law (LL.M.)

The seminar deals with International Investment Law, which is a special field of International Economic Law. The rules in investment treaties are intended to provide special protection for foreign investments – especially with regard to political risks such as expropriation and discrimination. The discussion in the context of the European free trade agreements with the USA (TTIP) and Canada (CETA) shows that International Investment Law is a very controversial field in International Law.

The participants are also expected to deal intensively with English-language literature and to conduct research at other universities for this purpose. They should independently familiarise themselves with the scientific literature. Visiting the two lectures on International Investment Law will be of great help for the participants.

The seminar will be held as a **block seminar**. A date for this will be announced. The seminar papers will have to be submitted in two printed versions as well as in one electronic PDF version. The electronic versions of the seminar papers will be sent to all participants for detailed preparation of the seminar. **Each participant is expected to engage in a thorough discussion of the papers of the other seminar participants.** 

Special attention is once again drawn to the formal requirements. Close attention will be paid to these and to compliance with the submission deadlines, as well as to **independent, proper and comprehensive literature research**.
